





Organisers' Checklist for-Scorecards

Tournaments in Australia are governed by Archery Australia rules. However, the Shooting rules are as per World Archery Rules, as this is a World Archery registered event.

Please note, due to logistics, because of the barebow test event, the Semi Finals on Saturday will not be shot with alternating scoring. They will be shot with simultaneous shooting.

For each scoresheet, make sure you check:

- Athlete name and surname is EXACTLY the same as per registered on Archers Diary
- □ AA Membership number correctly filled
- □ Date of event correctly filled
- □ Round of the event correctly filled
- □ Target number correctly filled
- □ Signature of both athlete and witness
- Check that all arrow values in Archer's Diary are exactly as per the paper score sheet
- □ Columns of Xs and 10s correctly counted
- □ 6 arrows score and progressive score is added correctly as per Archer's Diary

Any correction on the arrows score on paper scoring must be initialled by a judge before arrows on the target are touched.

Archers, please take note of some score sheet examples of what is acceptable and what is not acceptable o the following pages.

Example 1 - Correction of arrow score without judge verification and initial, score card will be void.

AA rule 7.20.5

'If an error is found in the entering of the value of an arrow on the scorecard, this may be changed providing no arrows have been removed from the target. Such a change can only be made by a Judge (or QRE Official at a QRE) after witnessing the arrows in the target. The Judge shall make the change in arrow value and duly sign the change in the area provided (Judges will use red ink for such changes) and ensure the other score sheet or electronic record matches.'

and

AA Rule 7.21.2

Outdoor and Indoor Target Events: A mistake on a scoresheet discovered before the arrows are drawn may be corrected, but the correction must be made and initialled by a Judge or Director of Shooting before the arrows are drawn. If the arrows have been drawn, no corrections to the arrow values as written on the scoresheet shall be permitted.







EXAMPLE 2 – Scorecard is acceptable because only the additions have been changed by the archers. See rule above.

EXAMPLE 3 - Scorecard is acceptable with a judge verification of altered arrow values only. Additions are up to the archers but scoresheet and Archers Diary total must be congruent.

EXAMPLE 5 – Illegible handwriting on scorecards the organising committee will consider the lower number arrow value that they can read.

WA Rule 14.4.1

The organisers are not required to accept or record scorecards that have not been signed, do not contain the sum total, and/or the number of 10's and/or the number of X's (or 9s for indoor) and/or which contain mathematical errors.

The organisers or officials are not required to verify the accuracy of any submitted scorecard, however if the organisers or the officials note an error or a missing signature at the time of submission, they will ask the athletes concerned to correct such error and the result as corrected will stand. Organizers may, but are not required to, have a process when the scorecards are submitted by the athletes to attempt to note an error or a missing signature. However, athletes are ultimately responsible for their portion of the scorecards and, if a paper scorecard is not submitted or is submitted without the athlete signature and not corrected at the time of submission, the athlete shall be disqualified (individual/team and mixed team where applicable) by the chair of the tournament judge commission. Any such corrections shall occur before the next stage of competition. Should a discrepancy be found in the sum total where:

• two paper scorecards are used, the sum total of the lower arrow scores will be used for the final result; if the score on a single scorecard (and in the case of double scoring, the score is the same on each scorecard), is lower than the actual score, the lower score on the scorecard will be used;







- one paper scorecard and one electronic scorecard are used, the total of the electronic scorecard will be used for total score, 10s and Xs on the following conditions:
 - o a total score has been entered on the manual scorecard so verification is possible;
 - in case no 10s and Xs (9s for indoor) are entered on the manual scorecard, no 10s and Xs (9s for indoor) are registered;
 - in case no total score is entered on the manual scorecard when it is submitted to the results team, then the athlete shall be disqualified (individual/team and mixed team where applicable).
